#### QUALIFICATION

Title: Level 2 Diploma in Controlling Lifting Operations – Slinger/Signaller (Construction)

### **TARGET DELEGATES**

This programme is aimed at individuals who hold a red CPCS card and need to achieve the relevant NVQ in order to convert to a Blue CPCS Competent Operator Card. For those who don't follow the CPCS Scheme, the qualification can be undertaken to underpin their competency in the role of Slinger/Signaller.

## **OVERVIEW**

In order to convert a CPCS Red Trained Plant Operator Card to a CPCS Blue Competent Operator Card, trained operators must achieve a Level 2 Diploma in Controlling Lifting Operations – Slinger Signaller.

As well as converting their card to a Blue Competent Operator Card, the candidate will also receive a nationally recognised qualification which will be issued by Cskills Awards. This proves that they have demonstrated their competency in the workplace.

Ainscough Training Services is a Cskills wards accredited assessment centre and we offer an assessment and verification service for candidates looking to achieve NVQs in Controlling Lifting Operations.

To achieve the qualification candidates must gather naturally occurring work based evidence which would include some or all of the following:

- Time sheets provided by the operator which are signed by the operator and manager
- Daily/weekly plant checks signed by the operator and manager or fitter
- Method Statements/Risk Assessments specific to the operator
- Copies of CPCS card and any relevant training certificates
- Any other documentation which is agreed as being valid by the assessor and candidate

Once the candidate has gathered the above evidence and when they feel ready to be assessed, one of our assessors will visit them at work on-site and observe them carrying out their normal work activities. Once our assessor is satisfied that the candidate has provided sufficient evidence they will be passed for verification and certification.

### **CERTIFICATION**

On completion of the qualification certificates of achievement will be issued from the awarding body; Cskills Awards. Provided the candidate has an in date Operatives Health & Safety Test the Blue Competent Operator Card can then be applied for. These cards last for 5 years.

#### **Important Information**

# Slinger/Signaller/Mobile Crane/Lorry Loader/ Tower Crane NVQs

## Qualification Process - 5 steps to gaining your NVQ

## STEP 1

On successful completion of the CPCS Technical Test you will be issued with the CPCS Red Trained Operator card in the Slinger/Signaller, Mobile Crane, Tower Crane or Lorry Loader category.

This card will last for 2 years and is non-renewable. During these two years you must undertake the relevant NVQ to progress to the blue Competent Operator card.

## STEP 2

Once you feel ready to start your NVQ we will arrange for one of our assessors to meet you to go through your induction at a convenient time and location.

During the induction your assessor will explain about the qualification and complete the registration paperwork with you. He will explain what evidence you will need to collect and issue you with your portfolio.

To complete the qualification you will need evidence of a lift you have taken part in.

You will also be observed on site by the assessor at a later date, you will need to gather evidence from this lift as well.

Your assessor will leave his contact details with you so should you have any questions or queries you can contact him as frequently as needed.

## STEP 3

Your assessor will contact you at least every 12 weeks to see how you are getting on and to make sure you have no difficulties with completing the qualification.

#### STEP 4

When an appropriate assessment opportunity becomes available, you will be asked to contact your assessor and arrange an observation. The assessor will meet you on site and observe while you are working. If the site allows he will take video and photographic evidence.

Evidence including time sheets, method statements and risk assessments for the observation and a previous job must be then sent to the assessor to complete the portfolio.

## STEP 5

Once the assessor is satisfied you have met all the criteria your portfolio will be passed for internal verification. After this your certificates will be applied for with the awarding body and then sent to you. Provided you have an in-date Health & Safety Touch Screen Test in the Operatives Category, you can then apply for your CPCS Blue Competent Operator Card.
