Royal British Legion – They advise to call Civvy Street direct on 0800 009 8015, Civvy street say as long as the course is not longer than 6 weeks they can consider applicants. SSAFA – Contact the local branch. They will assess if funding is available and it is determined on a welfare need which is not just financial; a welfare need could be working away from home for excessive amounts of time. <u>https://www.ssafa.org.uk/</u>

Help For Heroes – Potential applicants need have left the military over 2 years and be either medically discharged, in receipt of a war pension or have a service injury or illness that can be verified by a health care professional.

The diagnosis could be after they have left the military, but must be a result of their time in the military. If they comply to this criteria they can contact Help for Heroes for welfare, financial and general help.
